2014 REUNION UPDATE

The contract with the host hotel should be signed by issuance of this newsletter or shortly thereafter. On a parallel path, the Reunion Committee is selecting menus for our group buffet on Friday evening and banquet on Saturday night. The contract concerns group sales agreements—primarily guest room reservations—and establishes some basics for a separate catering contract. Meeting Rooms and their setups and meals are catering functions. The catering contract is easier and faster to deal with.


The Reunion Committee has yet to arrange for our tours but has some idea of suitable attractions based on information from the Seattle Convention & Visitors Bureau and suggestions from members in the area. One of the anticipated activities on Friday, 12 Sep, is a tour of the Trident Base in Bangor. Changes are being made for security purposes at all military bases because of the Washington Navy Yard shooting a few months ago. This situation, coupled with the government sequestration, has things on hold regarding arrangements for our base tour. This does not equate to no tour—it's a wait and see. The person at the base with whom I am dealing seems optimistic that we will get a base tour that will include a tour of a boomer. The Reunion Committee expects that all tours for the reunion will be arranged by mid-Feb 2014. We will incorporate alternates for the Trident Base tour should it be cancelled at the last minute. For Thursday during the reunion, we will be visiting attractions in the Seattle area that will include a visit to Pike Place Market for lunch and shopping in that area. Additionally, access to downtown Seattle from the host hostel will be easy via the Link (light rail) for those who want to "do their own thing." The 35-min. ride costs \$2.75.

I expect to issue the Reunion-Registration Packet no later than mid-Mar 2014. Meanwhile, please begin your plans to attend. As usual, you will not need to rent a car to get to the host hotel if all you will do is participate in the reunion. If you use any form of public transportation to arrive in Seattle, you will be able to arrive at the host hotel either by the hotel's complimentary airport shuttle or a combination of the Link from downtown Seattle to the airport and then the hotel's complimentary shuttle. The packet will provide more details.

We should have good attendance at this reunion as many of you have told me that you plan to attend. We may exceed the contracted block of guest rooms, but this will not be a problem as the hotel will be able to accommodate any overages at the contracted room rate as long as you make reservations before the cutoff date. Having fewer guest room reservations at the cutoff date than the contracted amount is the problematic situation.

The "important" stuff from decommissioned ships ends up under the control of the Naval Heritage & Command Center at the Washington Navy Yard. It is impossible to contact someone there, and with the government sequester in effect, the center is essentially shut down. The museum is under the control of the center, and its curator has volunteered to attempt to learn what happened to the stuff from Big Sam. I have not heard anything yet.

COMMENT ABOUT THE "SILENT SERVICE" VIDEOS

Tony lachovelli [MT2(SS), Gold, 1965—1970] had the following comment about the *Silent Service* DVDs that he purchased from the SHVA:

"I, too, was overly inspired by the TV series, **The Silent Service**. I was so inspired [that] I enlisted in the Submarine Reserves while still in high school! Upon graduating in June 1958, I attended Sub School for two weeks. In July 1958, I enlisted in the USN.

I attended Guided Missile School in Dam Neck, Va. after Boot Camp. At that time, two people from each class could volunteer for sub duty. Because they accepted people at the top of the class, I was not chosen. The next class only had one volunteer; so, they asked me if I was still interested. I said "yes," but I did not pass the physical (overweight). I had orders to attend Terrier [Missile] School on the west coast in three weeks. They gave me three weeks to lose 30 lb. By dieting, exercising, and 'greenies,' I lost 10 lb. in one week, 10 more in week two, but only 7 lb. in week three. The doctor said "no!" Everyone at Dam Neck knew what I was trying to do, especially the Corpsmen at the base hospital. They went into the doctor and said that this guy busted his ass; you have to let him go. He did. I went to Virginia Beach that night and had two lobsters with drawn butter and have not seen 190 lb. since!

I went to Sub School and got orders to USS George Washington (SSBN 598) in January 1960. I was aboard her when the first missile was fired from a sub. I served on four subs: 598, 601, 608, and 609 and made 12 Polaris Patrols. I was, and still am, inspired by those men of the "The Silent Service."



MORGAN EVANS, NEWLY FOUND SHIPMATE

Morgan Evans [RMCS(SS), Blue, 1976—1979] submitted the following information.

"Made warrant (CWO2) while at sea on Robert E. Lee (one patrol only as they needed someone in communications) and they pinned me, but when I made land, was told it was not official date yet so reverted back to Senior Chief and went back on the Sam Houston. I believe it was a short time later (1980) when Commander Klinger and my wife, Margaret, then pinned me again. When I was pinned on the Robert E Lee, came back to find the Chiefs had thrown my rack into the passageway and wouldn't let me back so I headed for officer quarters!"

The picture below is Morgan with his son, Morgan, clutching his sleeping bag as they prepare to go on a three-day patrol—probably around 1978. They slept down by the torpedoes and loved the experience.


Morgan Evans was aboard and remembers a few details about the incident.

"Near Guam and probably in 1978, Big Sam Blue Crew had fired an Exercise Torpedo that a Soviet AIG had picked up and later returned with a letter! May have been Patrol 50. After the Russians picked up our exercise torpedo, we followed the Russian AGI towards the Sea of Japan where eventually the torpedo was returned with a letter and bottle of vodka!

"All I remember was that we were firing our exercise torpedo, and the next thing I heard was that a Russian AIG had picked it up. I was in the Communications Room at the time of the incident and, eventually as I remember, the State Department became involved. The situation made national-TV news as my spouse became aware of the incident. The name of the submarine was not mentioned; so, she was not sure until we came home that it was our sub. The incident is mentioned in the book, Blind Man's Bluff."

CAPT David Klinger (CO, Blue, 1979—1981?) signed the back of the letter from the Soviets and gave it to Morgan for "his part in the incident." Pictures of that letter are on the next page. Morgan did not receive the bottle of vodka with that letter. My guess is that the Wardroom consumed it!


Submarine Commanding Officer!

Noel Barrnett [EM2(SS), Gold & SSN, 1980—1982] poses a question:





Richard Rocco [TM3(SS), Blue, 1967—1969] submitted the following memorabilia. These should bring back memories for most of us.


